## Display of draft version of Proposed Price Calculation Sheet for 11 proposed revised/notified ceiling price/retail price on NPPA's website.

NPPA has issued O.M. No. 8(34)/2016/DP/NPPA/Div.II dated 01.12.2016 referring Department OM No. 31015/44/2016 -PI.I dated 11.7.2016 regarding display of draft price calculation sheets for the proposed price notifications on the website of NPPA.

In this regard, 11 draft calculation sheet of Proposed Ceiling Prices/Retail Prices of the following Formulation based on Pharma Trac data is uploaded on the website.

- 1. Diclofenac Injection 25 mg/ml
- 2. Clobetasol Propionate IP 0.05% w/w + Neomycin Sulphate IP 0.50% w/w + Clorimazole IP 1.00% w/w + Chlorocresol 0.1% IP cream of M/s Pharma Force Labs./ M/s Gem Mankind

- 5. OLMESARTAN 40mg + HYDROCLORTHIAZIDE 12.5mg Tablet of M/s Indu Drugs Pvt. Ltd. / M/s Kardian Pharma (I) Pvt. Ltd.
- 6. HUMAN CHORIONIC GONADOTROPIN 2000 IU Inj. of M/s Sanzyme (P) Ltd. / M/s Sandoz Pvt. Ltd.
- 7. Nevirapine ER Tablet 400mg of M/s Emcure Pharmaceuticals Ltd
- 8. Dobutamine Injection 50mg/ml
- 9. Dopamine Injection- 40mg/ml
- 10. Atracurium Injection 10 mg/ml
- 11. Neostigmine -Injection 0.5 mg/ml

All the companies aggrieved by NPPA's proposed price fixation, may make representation, if any, against the proposed ceiling price/retail price by submitting documents/information of Price to Retailer (PTR) and Moving Annual Turnover (MAT) data along with supporting documents like copies of sample invoices to retailer and samples of August, 2015 duly attested with name, designation, mobile no., signature & seal of the authorized officer of the company along with the summary of all the invoices issued during the month of August, 2015 (giving details like Invoice No., Date, Name of Distributor & Retailer, Quantity, Pack Size, PTR (excluding VAT), Discounts/Free Goods, (if any) and copies of supporting Form-V/IPDMS, within 10 working days to NPPA in order to take necessary action in this regard.
